The Pierce Public Schools Board of Education met for their regular meeting on Monday, December 13, 2010, in the conference room at the high school, beginning at 6:00 p.m. Board members present were Jacque Collison, Klint Arnold, Ron Woslager, Ruth Jaeger and Kent Hanlin.
