The Pierce Public Schools Board of Education met for their regular meeting on Thursday, September 9, 2010, in the conference room at the high school, beginning at 6:00 p.m. Board members present were Jacque Collison, Ruth Jaeger, Misty Wortman, Klint Arnold, Ron Woslager and Kent Hanlin. Also present were Superintendent Dan Navrkal, Secondary Principal Mark Brahmer, Randee Falter of the Pierce County Leader, and guests.

Following the Pledge of Allegiance, a welcome was extended to the public. Haley Oestreich and Amy Fleer, representatives of the Pierce High School FFA, were present to explain Day of Service Project.

2010/11 Tax Request Resolution

Whereas, public notice was given at least five days in advance of a Special Public Hearing called for the purpose of discussing and approving or modifying the District's Tax Requests for the 2010/11 school fiscal year for the General Fund, Building Fund, & Bond Fund of Pierce County School District #2; and,

Whereas, such Special Public Hearing was held before the Board of Education of Pierce County School District #2 at the time, date and place announced in the notice published in a newspaper of general circulation, a copy of which notice and proof of publication of which is attached hereto as Exhibit A, all as required by law; and

Whereas, the Board provided an opportunity to receive comment, information and evidence from persons in attendance at such Special Hearing; and,

Whereas, the Board, after having reviewed the District's Tax Requests for each said fund, and after public consideration of the matter, has determined that the Final Tax Requests as listed below are necessary in order to carry out the functions of the District, as determined by the Board for the 2010/11 school fiscal year;

NOW BE IT THEREFORE RESOLVED that (1) the Tax Request for the General Fund should be and hereby is set at \$4,035,951.94 for the 2010-11 school fiscal year; (2) the Tax Request for the Building Fund should be, and hereby is set at \$181,952.51 for the 2010/11 school fiscal year; and (3) the Tax Request for the Jr./Sr. High School (7-12)

Bond Fund should be, and hereby is set at \$519,874.27 for District 2 of Pierce County and all affiliated school districts for the 2010/11 school fiscal year.

It is so moved by Jaeger and seconded by Woslager this 9th day of September, 2010.
