The Pierce Public Schools Board of Education met for their regular meeting on Monday, September 14, 2009, in the conference room at the high school, beginning at 6:00 p.m. Board members present were Jacque Collison, Misty Wortman, Clint Arnold, Ruth Jaeger, Kent Hanlin and Ron Woslager. Also present were Superintendent Dan Navrkal, Elementary Principal Sharen Luhr, Secondary Principal Mark Brahmer, Activities Director Gary Timm, and several guests.

A welcome was extended to the public. There was no communication from the public.

President Collison opened the Public Hearing of 2009-2010 budgets at 6:02 p.m. The Public Hearing was closed at 6:24 p.m.

Tax Request for the 2009/2010 school fiscal year for the General Fund, Building Fund, & Bond Fund of Pierce County School District #2; and,

Whereas, such Special Public Hearing was held before the Board of Education of Pierce County School District #2, at the time, date, and place announced in the notice published in a newspaper of general circulation, a copy of which notice and proof of publication of which is attached hereto as Exhibit A, all as required by law; and,

Whereas, the Board provided an opportunity to receive comment, information and evidence from persons in attendance as such Special Hearing; and,

Whereas, the Board, after having reviewed the District's Tax Requests for each said fund, and after public consideration of the matter, has determined that the Final Tax Requests as listed below are necessary in order to carry out the functions of the District, as determined by the Board for the 2009/2010 school fiscal year.

NOW BE IT THEREFORE RESOLVED that (1) the Tax Request for the General Fund should be, and hereby is set at \$3,731,941.37 for the 2009-2010 school fiscal year; (2) the Tax Request for the Building Fund should be, and hereby is set at \$111,167.67 for the 2009-2010 school fiscal year; and (3) the Tax Request for the Jr./Sr. High School (7-12) Bond Fund should be, and hereby is set at \$478,538.00 for District 2 of Pierce County and all affiliated school districts for the 2009/2010 school fiscal year.
