Doug Shelton-Current Co-Throws Coach at Pierce High. Coach Shelton has coached numerous throwers to state medals over the past 20 years.

Harliss Meaders—Head Throws Coach at Florida State University. Coach Meaders has coached many All-Americans and All-ACC throwers during his tenure at Florida State.

Ed McLaughlin-Throws coach at Concordia University, Seward, Nebraska. During his 10 year tenure at Concordia, he has coached 18 national qualifiers and 13 All-Americans. A Concordia alum, Coach McLaughlin was a six-time competitor at the NAIA Championship Meets.

Tyg Long—Head throws coach at South Dakota State University.

Derek Frese—Throws coach at Nebraska Wesleyan University. Coach Frese is a graduate of UNK and a native of Bancroft, NE. He was a 4 time NCAA Div. 2 All-American in the throws while a collegiate.

Aubrey Baxter—Three time NAIA National Shot-put and Discus Champion at Black Hills State University.

Adam Patrick— University of Nebraska graduate and thrower for the track team. Coach Patrick is currently the throws coach at Laurel High School in Laurel, Nebraska.

Les Piper— Co-Throws coach at Pierce High School. Coach Piper was a 50+ ft. shot putter and 160+ ft. discus thrower in high school.

Brett Suckstorf—Pierce High Graduate. Wayne St. College record holder in the weight and hammer throws. Current Big 12 runner-up in the weight throw and soon to be UNL hammer throw record holder.

Parent's Release and Indemnity Agreement
