Monday, August 13, 2012

The Pierce Public Schools Board of Education met for a special budget meeting on Monday, August 13, 2012, in the conference room at the high school, beginning at 5:45 p.m. Board members present were Jacque Collison, Misty Wortman, Ted Krienke, Kent Hanlin Ruth Jaeger and Klint Arnold. Also present were Superintendent Kendall Steffensen, Activities Director/Assistant Principal Gary Timm, Randee Falter of the Pierce County Leader and guests.

Following the Pledge of Allegiance, a welcome was extended to the public.

Discussion was held concerning the 2011-12 QCPUF (Qualified Capitol Purpose Undertaking Fund) budget which needed amending to reflect the expenditures for the elementary roof replacement. The final cost of the roof replacement was \$291,357. The QCPUF budget was adjusted to \$300,000.

Following discussion, a motion to adjourn the special budget meeting was made by Wortman, second by Arnold. Voting was unanimous, motion carried.

The regular meeting was opened with communication from Dan Unseld concerning a rumor about a salary increase and the 125 Plan. Mr. Steffensen responded to the inquiry.

A motion was made by Arnold, second by Jaeger to accept the consent agenda which included the financial reports, band statements, bills and four option requests (3 opting in and 1 opting out). Voting was unanimous, motion carried.
