Motion by Arnold, second by Wortman to trim \$400-425,000 from the budget due to budget shortfall reductions with the following reduction in force proposal: Reduce three teachers from the elementary program; reduce one teacher from the art program; reduce one teacher from the vocal music program, reduce one teacher from the technology maintenance program; reduce one teacher from the curriculum/school improvement program. Voting was unanimous, motion carried.

Motion by Jaeger, second by Hanlin, to adjourn at 6:47 p.m. Voting unanimous, motion carried.
