The Pierce Public Schools Board of Education met for their regular board meeting at 6:31 p.m. in the High School conference room. Members present were Dan Unseld, Robert Hoffmann, Kent Hanlin, Ted Krienke, Jacque Collison, and Dave Lienemann. Also present were Superintendent Kendall Steffensen, High School Principal Mark Brahmer, Assistant Principal/Activities Director Johnnie Ostermeyer, Elementary Principal Adam Patrick, and eight guests.

A welcome was extended to the public and the Pledge of Allegiance was recited. The Open Meetings Act was pointed out.

Collison moved and Lienemann seconded a motion to approve the consent agenda of minutes of the previous meeting, claims and payments of bills, and financial reports. Voting unanimous, motion carried.

Autumn Baumann and London Sindelar gave the FCCLA report. They told about candy grams, officer interviews, and pledges for mentally challenged awareness.
