***Gain Both Experience and Knowledge from Some of the Best College and High School Throws Coaches in the Region:***

**Scott Campos** – University of Nebraska Throws Coach – The current coach of Nick Percy, the reigning NCAA Division 1 discus champion.

**A.G. Kruger** – University of South Dakota Throws Coach – Coach Kruger is a 3-time Olympian, competing in the hammer throw in the 2004 Athens, 2008 Beijing, and 2012 London Olympic games. He has competed on 5 World Championship Teams and has qualified for 14 U.S. National Championships. In 2014, Coach Kruger broke the American record in the 35 lb. weight throw as well as the 56 lb. ultra weight throw. He is a graduate of Morningside College and is a native of Sheldon, Iowa.

**Doug Shelton** – Current Throws Coach at Pierce High School. Coach Shelton has coached numerous throwers to state medals over the past 25 years.

**Derek Frese** – Nebraska Wesleyan University – 4 time All-American at the University of Nebraska-Kearney. Coach Frese has coached 8 All-Americans and 11 National Qualifiers as well as numerous All-Conference throwers while at Wesleyan. Coach Frese was also named the 2010-2011 Central Region Track & Field Coach of the Year.

**Ed McLaughlin** – Concordia University – During his 19 year tenure at Concordia, Coach McLaughlin has coached 51 All-Americans, 65 National Qualifiers, 8 National Champion Runners-up, and numerous All-Conference throwers.

**Brett Suckstorf** – Wayne State College – Coach Suckstorf is the head throws coach at Wayne State College where he is the holder of the hammer and weight throw records. After two years at Wayne State as a collegiate thrower, Coach Suckstorf transferred to the University of Nebraska where he finished as the 2<sup>nd</sup> best all-time Hammer and Weight Thrower ever at UNL. As the throws coach at Wayne State, Coach Suckstorf was named the 2014 National Assistant Coach of the Year in NCAA Division II. He has coached 10 All-Americans and 17 National Qualifiers. During the 2015 season, Suckstorf coached Sara Wells to national championships at both the national indoor and outdoor meets.

**Samantha Dolezal** – 6 Time Discus All-American from Nebraska Wesleyan

**George Blum** – Howells-Dodge High School

**Carly Fehringer** – Wayne State College – Carly was a 4-time All-American while at Wayne State and was a high school state meet qualifer as well.

**J. Wewell** – **Factory Representative for BLAZER Shot and Discus Company** – Mr. Wewell will be at the camp to demonstrate Blazer products and to allow coaches and athletes the opportunity to buy shots and discs at discount prices. He will also hold a drawing for 4 free discs and shot puts for the participants attending the camp.
