## Monday, September 12, 2022

The Pierce Public School Board of Education met for the regular monthly meeting at 6:30 pm in the commons area of Pierce High School. Members present were Ted Krienke, Dan Unseld, Kevin Flesner, Adam Venteicher, Lisa Freeman, and Craig Peters. Also present were Superintendent Kendall Steffensen, High School Principal Mark Brahmer, Activities Director Darren Sindelar, and twenty-three guests. Notice of the meeting was printed in the Pierce County Leader and posted on Pierce Public Schools website.

A welcome was extended to the public, the open meetings act pointed out, roll call taken, and the Pledge of Allegiance was recited.

Jerald Wachter, Bill Brookhouser, Katie Prince, Scott Abler, Kate Siebrandt, Sheila Abler, Steve Prince, Ayden Thelen, and Jeff Andersen spoke in the public communication and correspondence portion of the meeting.

Venteicher moved and Flesner seconded the motion to approve the consent agenda consisting of the approval of minutes from the previous meeting, approval of claims and payment of bills, and financial reports. Voting Unanimous, motion carried.

Hayden Magnussen and Brielle Unseld spoke on what FFA has done throughout the summer. Many members have competed in livestock judging, setting up for the fair, and competing in the fair. This year there are approximately 70 members on roster.
