The Pierce Public Schools Board of Education has called a school bond election **in an amount of \$25,995,000** for the purpose of constructing additions and renovations and other site improvements to the existing elementary and high school buildings.

1 Safe, Secure, & Modern Facilities

Outdated intercom systems, lack of storm shelters, unsecured entrances compromise student safety and emergency preparedness.

2 Space for Growth & Privacy

Overcrowded classrooms, shared gym/cafeteria spaces, and insufficient rooms for special education and mental health services limit learning potential and privacy for those who need it most.

3 Improved Learning Environments

Modernized spaces with proper heating, cooling, and technology support uninterrupted, comfortable learning. Upgrades will support current educational programs and prepare students for future careers, including trade and ag-based jobs.

4 Expanded Opportunities in Arts & Athletics

Students in theatre, band, and art deserve updated performance spaces, just as athletes need adequate gyms, weight rooms, and facilities for growing programs like girls' wrestling.

5 Better Community Access & Economic Impact

New and improved facilities will attract events, tournaments, and community use—bringing pride and economic benefit to our town.

6 Efficient Use of Resources

Instead of pouring money into outdated, non-code-compliant buildings like the current auditorium, the plan provides smart, sustainable solutions for long-term success.




